This is not a drop-off event. Please make sure that your child has adult supervision!

- Tournament is open to all current Benninghoven students. Teams may be any mix of genders/ages/grades.
- Entry fee: \$100 per team of eight (8) players. All players start on the court (no substitutions).
- Each team must have a designated team coach.
- A "ringer" may be purchased for the team for \$20. Ringers are optional. (More info below.)
- New for 2019: Team Spirit Award!
- Concessions and Spirit Wear will be available for purchase.
- Registration is limited to the first 16 teams to turn in a completed registration packet and entry fee (see following page) to the school office.
- Deadline for entry is **February 12, 2019** (or until tournament is filled with 16 teams).

TEAM REGISTRATION INFORMATION

- Teams may pay an additional \$20 to add a ringer to their team as an extra (9th) member. Teams must recruit their own ringer if desired. Ringers may be siblings, parents, relatives, community members, teachers, staff members, etc. Ringers must sign a waiver and abide by the same rules as players and coaches.
- The schedule of games will be posted the week of the tournament, however, there are no specific game times. Teams are encouraged to be present at 1:00 pm and stay for the entire event.
- Teams must be present in the pre-game area prior to their game. Failure to be present in the pregame area can result in a forfeit.
- There will be a **mandatory coaches meeting** on the evening of **February 13** to distribute and discuss tournament rules and answer questions. If the coach is unable to attend, a parent from the team must attend in their place. The coach or parent attending the meeting is responsible for disseminating pertinent information to the team.
- Team shirts are not required but may be arranged by the team if desired.
